IN CONSIDERATION of the acceptance by Western Modlite Association, of this membership agreement, the payment of the required fee, the issuance of a Western Modlite Association Annual Membership Permit, by being permitted on the speedway or raceway premises of any Western Modlite Association sanctioned event, or any of the foregoing, I, for myself, my heirs, next of kin, personal representatives, and assigns, hereby agree (in accordance with Arizona law) as follows:

To comply with the Western Modlite Association Official Rules and Regulations (as amended); To abide by the decisions of the Western Modlite Association Officials; To be bound by the procedures for and results of protests and appeals, which shall be the exclusive remedy for any aggrieved driver; To waive any right to litigate and decision of the Western Modlite Association Officials or the results of any Western Modlite Association event;

To release, waive, discharge, give up all my rights to sue or make claim against, and covenant not to sue Western Modlite Association organization, Western Modlite Association Officials or and other Western Modlite Association driver and each of them from all liability to the licensed or permitted driver, his personal representatives, assigns, heirs or next to kin for any and all loss or damage and any claim or demands therefore on account of or resulting from injury to person or property or resulting in death of the licensed or permitted driver, whether caused in whole or in part by the negligence or any other wrong doing of Western Modlite Association , Western Modlite Association Officials, or any other Western Modlite Association driver while the licensed or permitted driver is in or upon the speedway grounds and/or competing, observing, or for any purpose participating in the event;

To indemnify, save and hold harmless Western Modlite Association , Western Modlite Association Officials and other Western Modlite Association drivers and each of them from any loss, liability, damage or cost they may incur due to the presence of the licensed or permitted driver in or upon the speedway grounds or in any way competing, observing or for any purpose participating in the event and whether caused in whole or part by the negligence or any other wrongdoing of Western Modlite Association, Western Modlite Association Officials, or Western Modlite Association drivers or otherwise;

To assume full responsibility for and risk off bodily injury, death or property damage due in whole or in part to the negligence or any other wrongdoing of Western Modlite Association, Western Modlite Association Officials, and other Western Modlite Association drivers while in or upon the speedway grounds and/or while competing, observing, or any purpose participating in the event;

To reimburse the attorney’s fees, expert witness fees, court costs, and all other expenses incurred by Western Modlite Association, and Western Modlite Association Officials in any litigation commenced by or on behalf of the licensed or permitted driver, his personal representatives, assigns, or next of kin, regardless of the outcome of any such litigation;

To waive any right to jury trial; To the exclusive jurisdiction and venue of the Court of Maricopa, Arizona;

I HEREBY CERTIFY that any license or permit granted hereunder is granted for the sole purpose of enabling me to participate in the furtherance of an enterprise, a race, or other motorsports-release activity. My presence in, about, or en-route into or out of any premises where Western Modlite Association sanctioned events are presented in furtherance of that Western Modlite Association event.
